

# IPSAL: Implementation of the module to generate the Sobol sequence and indices<sup>☆</sup>

## IPSAL: Implementação do módulo para geração da sequência e índices de Sobol

### Abstract

Sensitivity and uncertainty analysis hold significant importance across a range of applications, spanning from industrial problems to climate change, financial risk assessment, as well as mathematical and computational models. These analyses involve identifying influential input parameters in models to comprehend their impact on the output. Sensitivity analysis can be performed locally, examining parameter effects at a fixed value, or globally, evaluating the model across a range of parameter values. The Sobol method stands as a robust approach for global sensitivity analysis, employing a Sobol sequence to create samples more uniformly within the input parameter space, thus enabling efficient exploration of model inputs. This paper aims to introduce a computational implementation in Scilab to generate the Sobol sequence for utilization in sensitivity analysis through the Sobol method. A test case was applied to generate Sobol sequences and discuss the obtained results.

### Resumo

A análise de sensibilidade e da incerteza tem uma importância significativa numa série de aplicações, abrangendo desde problemas industriais até alterações climáticas, avaliação de riscos financeiros, bem como modelos matemáticos e computacionais. Essas análises envolvem a identificação de parâmetros de entrada influentes nos modelos para compreender seu impacto na saída. A análise de sensibilidade pode ser realizada localmente, examinando os efeitos dos parâmetros em um valor fixo, ou globalmente, avaliando o modelo em uma faixa de valores de parâmetros. O método de Sobol apresenta uma abordagem robusta para análise de sensibilidade global, empregando uma sequência de Sobol para criar amostras de forma mais uniforme dentro do espaço de parâmetros de entrada, permitindo assim a exploração eficiente das entradas do modelo. Este artigo tem como objetivo apresentar uma implementação computacional no Scilab para gerar a sequência e os índices de Sobol para utilização em análise de sensibilidade através do método Sobol. Um caso de teste foi aplicado para gerar sequências de Sobol e discutir os resultados obtidos.

# 1 Introduction

In various applied problems, such as industrial scenarios, climate change, financial risk analysis, physical mathematical models, and computational models, input data and parameters shaping the model are considered. To question the significance of these pieces of information and their effects in such applications, a direct analysis is conducted to facilitate fundamental decision-making across diverse contexts. In this context, the utilization of sensitivity and uncertainty analysis emerges to pinpoint the most influential inputs in a model, allowing for an in-depth understanding of their effects on the model's output [1].

Engaging in sensitivity analysis is essential to comprehend the behavior of the studied model concerning its input parameters. For inverse problems, for instance, a parameter lacking influence on the model's output should be excluded from the optimization process [2], as any value assigned to this parameter will yield the same output. The sensitivity study of the model concerning input parameters can be approached from two perspectives: local and global sensitivity analysis [3]. According to Ref. [4], one approach complements the other. The local approach assesses the model's sensitivity for a fixed parameter value across the entire model domain. The global approach evaluates sensitivity at a specific point in the model domain for various parameter values. There are specific methods to address both approaches. In this article, we delve into the Sobol method for global sensitivity analysis.

A central point for applying Sobol sensitivity analysis is the use of the Sobol sequence, a pseudo-random sampling approach introduced by Sobol [5]. Unlike random sampling sequences, such as those generated through the Monte Carlo method, which is used to approximate solutions for problems analytically challenging or impossible to solve, the Sobol sequence guarantees a more uniform coverage of the sample space, rendering it more efficient and precise [6]. Through the Sobol sequence, the capability to adequately explore the model input is enhanced, generating valuable insights for decision-making, including process optimization, identification of influential variables in models, thereby enabling process enhancement to boost efficiency and production quality, social sciences modeling, extensively applied across scientific domains as a potent tool for sensitivity analysis in mathematical models [7], physicochemical models [8], biological models [9], among others.

This article presents the implementation of a portion of the sensitivity analysis module using the Sobol method for the Inverse Problem and Sensitivity Analysis Library (IPSAI). It encompasses the development of the Sobol sequence and a test case.

# 2 Materials and Methods

In this section, an algorithm for generating the Sobol sequence is presented. The process involves converting decimal numbers into binary numbers, including the fractional parts, and performing the unconventional bitwise operation *bit by bit* [10], denoted as  $\mathbf{u} \oplus \mathbf{v}$ , where  $\mathbf{u}$  and  $\mathbf{v}$  are vectors containing each digit from the binary decomposition of the decimal number. The unconventional operation is defined as  $1 \oplus 1 = 0$ ,  $1 \oplus 0 = 1$ ,  $0 \oplus 1 = 1$ , and  $0 \oplus 0 = 0$ . The Sobol method for sensitivity analysis involves generating a sample space composed of Sobol sequences to evaluate the model's sensitivity concerning its inputs. This sample space is derived from the unit hyper-edges of the hypercube [11]. In this work, model parameters are considered as inputs, and  $d$  represents the number of input parameters.  $d$  signifies the dimension of the hypercube, i.e.,  $[0, 1]^d$ , wherein the goal is to create a set of values, the Sobol sequence, contained within each of the hyper-edges.

## 2.1 Sobol Sequence

The Sobol sequence is denoted as  $S_n$ , where  $n = 1, \dots, r$ ,  $r$  is the total number of sequences, indicating the sequence position, and each of its components as  $S_{n_j}$ ,  $j = 1, \dots, d$ . The set  $S_n = (S_{n_1}, \dots, S_{n_d})$ . Each component of the sequence satisfies  $0 \leq S_{n_j} < 1$ ,  $j = 1, \dots, d$ . To calculate  $S_{n_j}$ , the following equation is used:

$$S_{n_j} = b_{n_1} v_{j_1} \oplus b_{n_2} v_{j_2} \oplus b_{n_3} v_{j_3} \dots b_{n_k} v_{j_k} \tag{1}$$

where  $j = 1, \dots, d$ , and  $k$ , the last term in the unconventional summation in equation (1), depends on the binary decomposition of the integer  $n$ , i.e.,  $(n)_{10} = (bn_1b_{n_2} \dots b_{n_k})_2$ .

In equation (1), the term  $v_{j_i}$  is introduced, representing binary fractions with a denominator of  $2^i$ , i.e.,

$$v_{j_i} = \frac{m_{j_i}}{2^i} \tag{2}$$

The terms  $v_{j_i}$ ,  $j = 1, \dots, d$ , are referred to as directional numbers, with the variation in  $i$  depending on the total number of bits in the decomposition of  $n$  in base 2. The numbers  $m_{j_i}$ ,  $j = 1, \dots, d$ , are defined by

$$m_{j_i} = 2a_{j_1} m_{j_{i-1}} \oplus 2^2 a_{j_2} m_{j_{i-2}} \oplus \dots \oplus 2^{q-1} a_{j_{q-1}} m_{j_{i-(q-1)}} \oplus 2^q m_{j_{i-q}} \oplus m_{j_{i-q}} \tag{3}$$

Where  $q = d + 1$  as presented in Eq. (3), referring to the degree of the polynomial given in Eq. (4). The coefficients  $a_j, j = 1, \dots, d$ , are obtained from an irreducible polynomial in the field  $\mathbb{Z}_2$  over the set  $\{0, 1\}$  with addition modulo 2 and the standard multiplication, given by

$$p(x) = x^{d+1} + a_1x^d + a_2x^{d-1} + \dots + a_dx + 1 \tag{4}$$

Thus, the coefficients  $a_j$  take on values of either 1 or 0. It is necessary to initialize the first three terms  $m_{j_1}, m_{j_2}$ , and  $m_{j_3}$  as odd integers smaller than  $2^i$ .

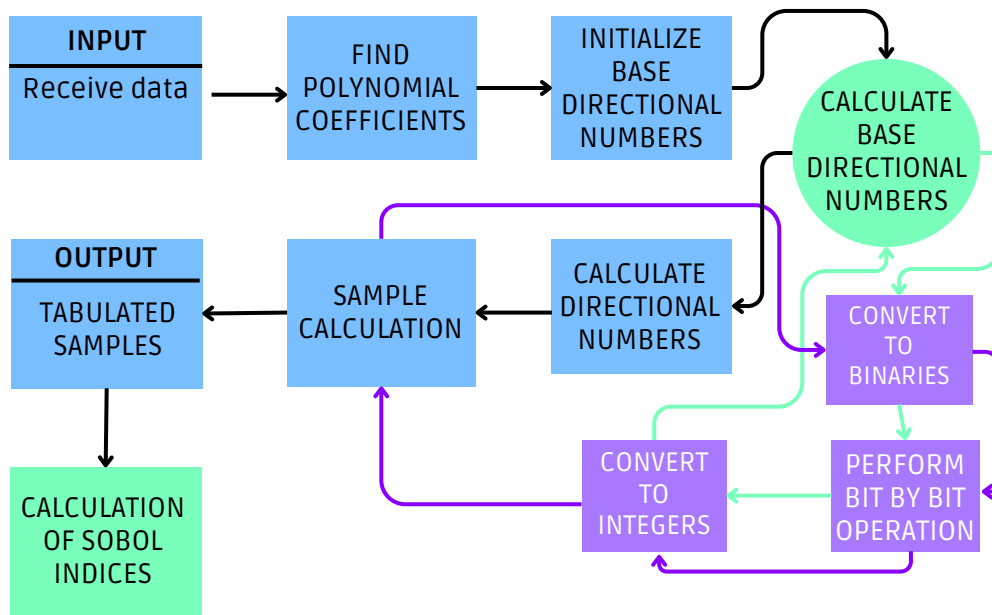


Figure 1: Flowchart for Sobol Sequence Generation

In Figure 1, the workflow diagram of the Sobol sequence generation algorithm is presented. The unconventional bitwise operation is performed twice but under different circumstances. Initially, when calculating  $m_j$  in Eq. (3), the conversion between binary and integer is performed. Subsequently, when calculating  $S_{n_j}$  in Eq. (1), the operation is carried out between the decimal and binary parts.

## 2.2 Sensitivity Analysis

Sobol sensitivity analysis is a technique used to evaluate the relative importance of input variables in relation to the output of a model. The order of Sobol sensitivity indices depends on the degree of interaction between the variables.

The most important factors for carrying out the sensitivity analysis are the table of values taken from the Sobol sequence, the expected value of the function and its average.

The Sobol sensitivity index is given by

$$S_i = \frac{V(f|x_i)}{V(f)} \tag{5}$$

where  $S_i$  is the sensitivity of the function with respect to the variable  $x_i$ ,  $V(f|x_i)$  is the variance conditioned on the variable  $x_i$ , and  $V(f)$  variance of the function  $f$ . This coefficient is called the first-order coefficient, and tells us how sensitive the function is to each of the input variables.

## 2.3 Computer code

The IPSAL library should be downloaded and saved in the user's working folder. Afterward, the library functions for the Sobol method should be declared.

To generate the Sobol sequence, after calculating the directional numbers (direcao.sci), the following code is used.  $r$  input's with  $d$  parameters each will be generated. Each entry in this sequence will be used in the model to calculate the Sobol indices.

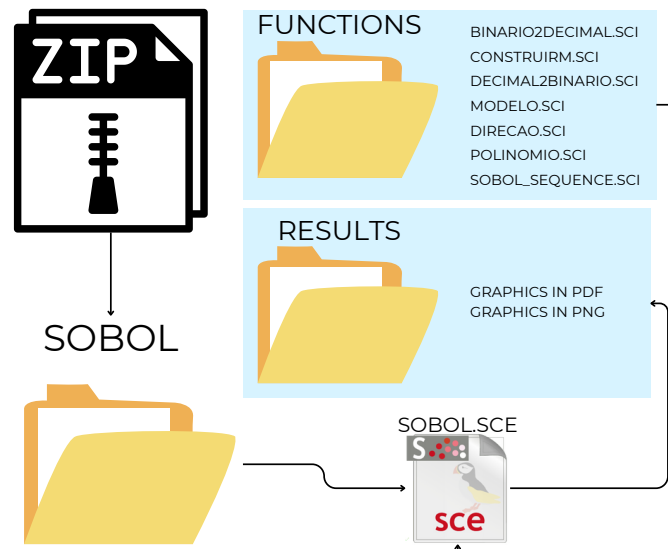


Figure 2: Organizational structure of the code.

In Figure 2, the organizational structure of the code developed in Scilab is illustrated. The *results* folder will be responsible for storing all the outcomes obtained with the method.

The Sobol method module in Scilab can be accessed by the Computational Modeling, Inverse Problems and the Environment repository.

### 2.4 Test Case

The function given by

$$f(\mathbf{x}) = x_1 + x_2^2 + x_2 \cdot \sin(x_3) + x_4 \tag{6}$$

where  $\mathbf{x} = (x_1, x_2, x_3, x_4)$  represents the input data, will be considered.

A Sobol sequence,  $S_n, n = 1, \dots, r$ , will be constructed in the hypercube of dimension  $d = 4, [0, 1]^4$ , to evaluate the sensitivity of  $f(\mathbf{x})$  (Eq. (6)) with respect to the inputs  $\mathbf{x} = (x_1, x_2, x_3, x_4)$ . To achieve this, four irreducible polynomials of degree 5 will be constructed within  $\mathbb{Z}_2$ . The polynomial is given by

$$p_j(\mathbf{x}) = x^5 + a_{j_1}x^4 + a_{j_2}x^3 + a_{j_3}x^2 + a_{j_4}x + c \tag{7}$$

where  $j = 1, \dots, 4, i = 1, \dots, 3$ , and each  $a_{j_i}$  is randomly obtained, taking on values of either 0 or 1, ensuring that at least one  $a_{j_i}$  is equal to 1.

## 3 Results and Discussion

The test case described in Eq. (7) was used to generate the Sobol sequences. The construction will be to evaluate the four inputs,  $x_1, x_2, x_3$  and  $x_4$ , with  $d = 4$ . After running the computational code elaborated in Scilab to generate 500 samples, in Table 1 we observe the first ten Sobol sequences obtained. Up to the sequence 4 there is a repetition of values [1].

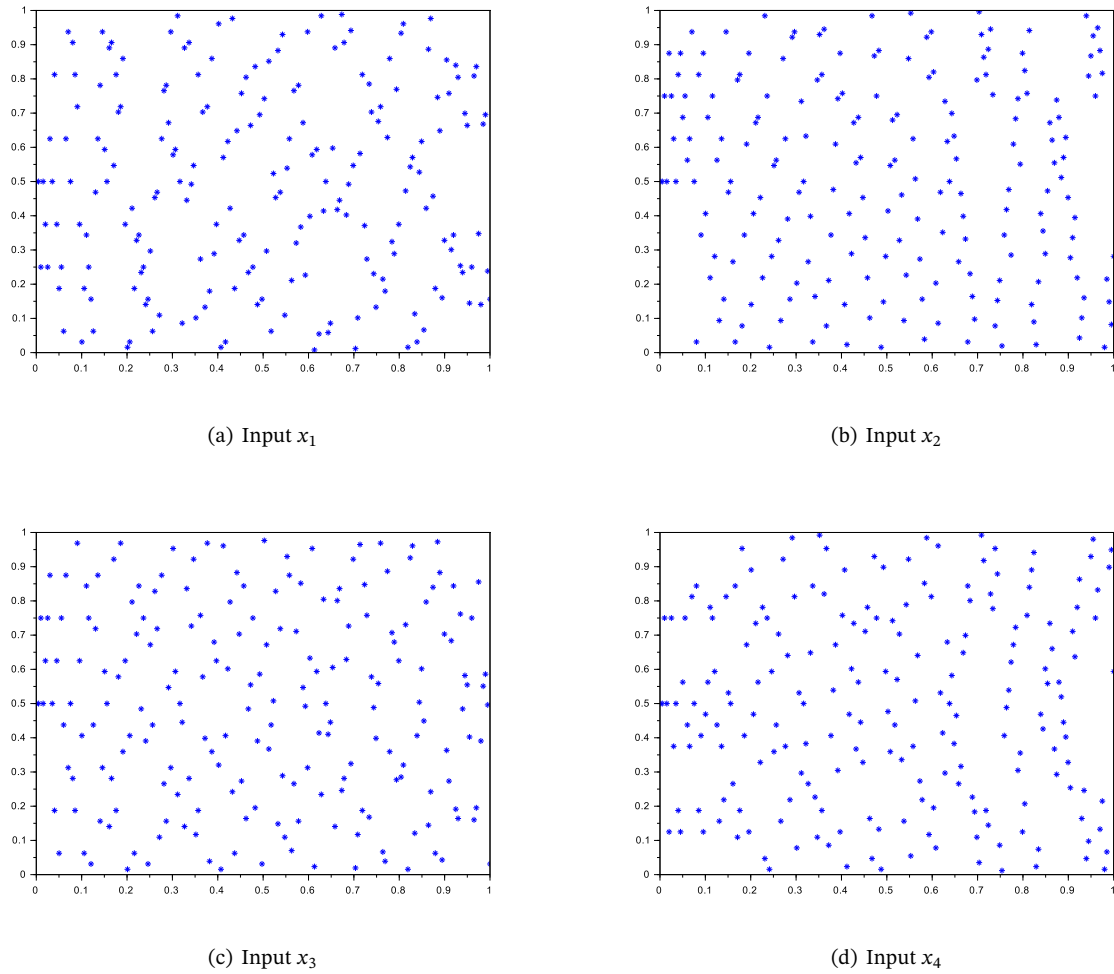


Figure 3: Distribution of Sobol sequences for each model input for  $n = 200$ .

To observe the distribution of Sobol sequence values for each input, the computational code was run for three different quantities. First,  $n = 200$  was used, as can be seen in Fig. 3. For all inputs an almost uniform distribution was obtained.

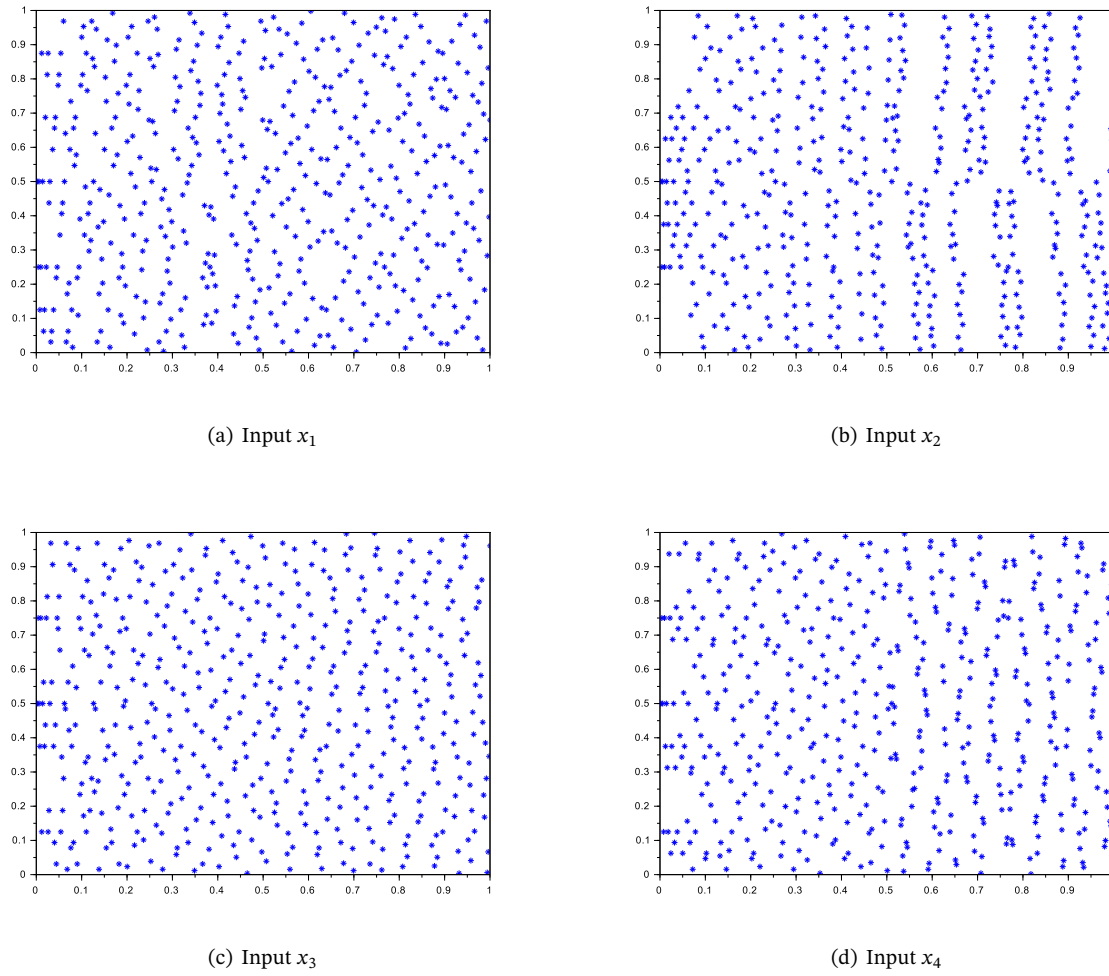


Figure 4: Distribution of Sobol sequences for each model input for  $n = 500$ .

Then,  $n = 500$  was used, as presented in Fig. 4. The distribution of Sobol sequences remains almost uniform.

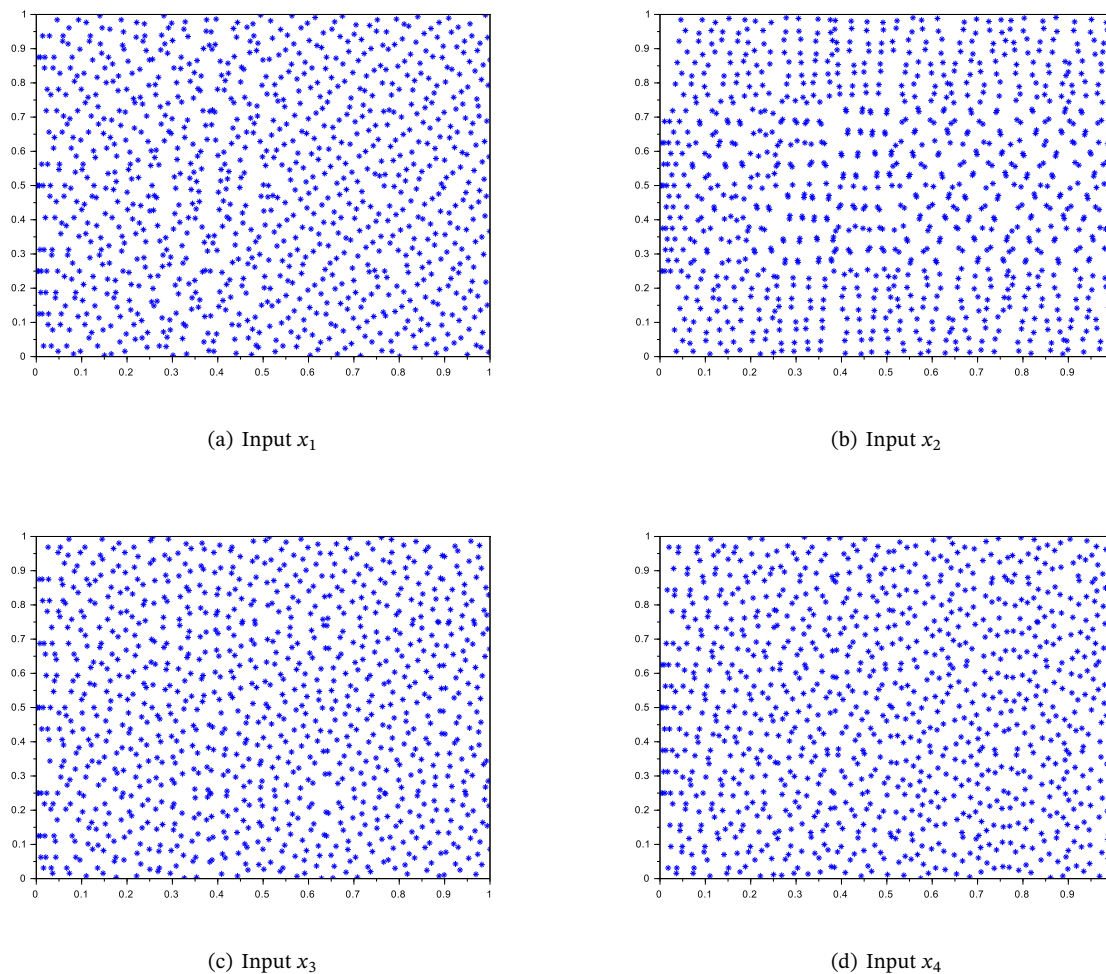


Figure 5: Distribution of Sobol sequences for each model input for  $n = 1000$ .

Finally,  $n = 1,000$  was used, according to Fig. 5. Again, the distribution of Sobol sequences remains almost uniform.

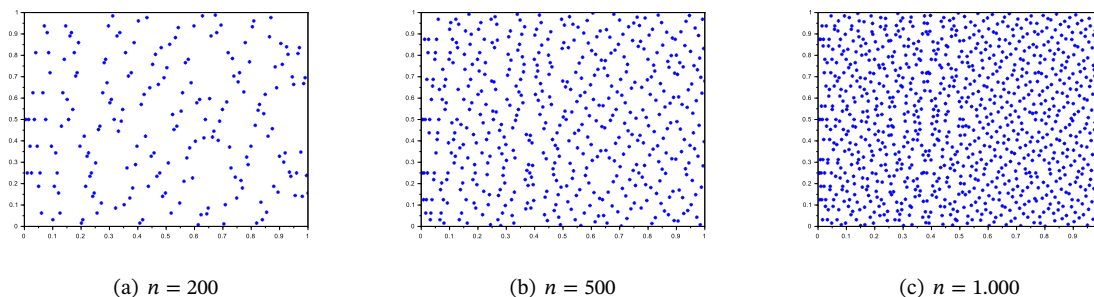


Figure 6: Distribution of Sobol sequences for input  $x_1$  ad  $n = 200, n = 500$  e  $n = 1.000$ .

Figure 6 shows the distribution of the samples obtained in the generation of the Sobol sequence for the input  $x_1$ , for a total of 200, 500 and 1000 sequences. It is possible to observe the evolution of the distribution, which remains almost uniform.

The first order Sobol indices present the sensitivity of the model with respect to each  $x_i$ , see Table 2. The function is sensitive to all inputs. The inputs  $x_1$  and  $x_4$  are less influential in the function due to their linear nature, as can be seen in Eq. (7).

## 4 Conclusion

The IPSAL library allowed the application of sensitivity analysis techniques and inverse problems with just a few commands. It is currently being implemented in Scilab, but will also be translated into other programming languages. The implementation of Scilab currently allows sensitivity analysis using the Morris method and, as the study objective of this article, sensitivity analysis using the Sobol method. After generating the Sobol sequence, the first order indices are used to perform Sobol sensitivity analysis. The test case, Eq. (6), was used to observe the distribution of Sobol sequences for the model inputs, highlighting their almost uniform behavior. The Sobol indices show that the function is sensitive to all inputs, with inputs with a linear effect having lower values in the index. As future work, higher order indices will be implemented, which will allow analyzing the correlation between the function's inputs.
